The Precaution Academy is an introduction to new ways of strengthening democratic society, preventing harm to the environment and improving human health.

The purpose of the Precaution Academy is to:

- Prepare participants to apply precautionary thinking and action to problems in their home communities and workplaces;
- Familiarize participants with the history of the regulatory system, quantitative risk assessment, and the development of precautionary thinking.
- Clarify the uncertainties involved in contemporary problems and the role of precaution in addressing uncertainty;
- Prepare participants to respond to criticisms of the precautionary approach;
- Help participants reframe familiar problems and issues within a precautionary framework, and to explore how prevention differs from problem-management.
- Familiarize participants with the many ways that precaution is being applied in the U.S., Canada and abroad so they can apply it at home.

supplemented by a short workbook of articles.
